- 1) Choice of conductor and secretary of the meeting (minute-taker?)

- 2) The board's account of the past year.
- The club went into lockdown due to the current pandemic.
- We lost Simon and Darko.
- No events were attended.
- The club invested in a rapier and a dagger.
- Membership dues were suspended due to the lockdown of the club.
- The window for renewal of the leasing of the gym was exceeded. Casper has contacted 'Sport og Fritid' and sought to fix the situation. It is expected that this will be solved. Otherwise, an alternative arrangement will have to be made.
- 3) Presentation of the annual report of the treasurer.
- The total amount of membership fees paid in 2020 was 11200 DKK.
- 10-11 paying members. This number is likely skewed due to the fee suspension.
- The annual report was unanimously approved.
- 4) Presentation of the board's budget suggestion for the coming year.

- Leif was unanimously chosen as treasurer for the coming year.
- 9) Choice of secretary for the club.
- René was chosen for secretary.
- 11) Choice of alternate for the board.

- Anders was chosen as alternate.
- 12) Choice of accountant.
- Adam volunteered to be the accountant for the coming year as a way to ease the transition for the new Treasurer.
- 13) Additional discussion.
- It is currently unknown when the club can reopen for indoor practice.
- It was suggested that the first hour should be for beginners or the advanced people. This suggestion evolved to a suggestion that advanced members train from 19:00 to 20:30 and beginners train from 20:30 to 21:30. Casper will let the potential new people know once we have an opening date.
